# Call for Participants Keep Democracy Great!

**Training Course for Youth Workers** 

27 November – 06 December 2020, Slettestrand, Denmark

Together with our partners, we are looking for participants from: Denmark, Hungary, Lithuania, Greece, Poland, Portugal, Turkey and Spain - for the **Training Course "Keep Democracy Great! 27 November – 06 December 2020, Slettestrand, Denmark** 

#### **Summary:**

"Keep Democracy Great! Is a Training Course, that will be conducted in Slettestrand, Denmark. The training course will provide the participating youth workers with methods and tools to deepen their understanding of the concept of democracy, as well as to improve their competences upon how to transfer the knowledge about the importance of democratic values to young people in their local community.

The aim of the project is to promote and maintain the current democratic values and strengthen the belief of its importance amongst young people.

The objectives of the Training course are:

- a) To deepen youth workers' understanding upon the meaning and importance of democracy, also the role of the European Union to preserve it.
- b) To deepen youth workers' understanding upon the factors which can decrease the strength of democracy and the effects of its deconsolidation.
- c) To equip youth workers with skills and competences how to maintain democracy: critical thinking, detection of fake news, fighting populism.
- d) To raise youth workers' awareness on the current political issues, and how to be active citizen in Europe.
- e) To provide youth workers with new non-formal methods by which they will promote the importance of democracy and the participation in democratic life amongst young people.
- f) To raise youth workers' confidence in organising local activities upon promoting the values of democracy designed by non-formal methods.

The Training Course will be conducted in English and translation will not be provided. Therefore, the participants are expected to have an intermediate level of English, both written and spoken.



# Participants profile:

The primary selection criterion is that the participant shall understand the aim and objectives of the project and shall be willing to foster its completion. Beside of that, the participant of the training course shall:

- Be a youth worker and be involved in the deliverance of non-formal learning for young people.
- Be above 21 years old. Persons under 21 years of age, may be considered based on motivation and experience.
- Be committed to take part in the whole duration of the training course, and be willing to be active on the training course and work in a multinational environment.
- Be willing to make dissemination activities to share the results of the project.
- Be at least on an intermediate level in English Participant selection.

In order to participate, the candidates should be motivated to promote the concept of democracy amongst local young people, but in need of acquiring the necessary capacity to strengthening their own understanding and knowledge upon the importance of democratic values.

Candidates who do not fulfil the above requirements will not be considered.



#### **Deadlines**

The candidates should have completed and submitted the application form **no later than 23<sup>rd</sup> October 2020**. Confirmation of the participant selection will be announced by the organizer on 26<sup>th</sup> October 2020 the latest.

Within 5 days after the selection results are announced, participants must purchase their travel tickets to the activity venue and send the organisers a copy of these.



#### **Travel**

The EU contribution for the travel expenses per participant is as follows:

<sup>\*</sup>For participants from Turkey, funds of up to 150€/person are available to contribute to visa costs, where needed. Cost are reimbursed based on the documented real costs, and not more than 150€/person.

The travel contribution was calculated using the <u>distance calculator</u> of the European Commission from the location of each sending organization to the venue. Should the travel expenses exceed the contribution available, participants shall cover the extra costs from own resources.

Participants are responsible to arrange their travel insurance in cooperation with their sending organisations covering them for the whole duration of the training course. The costs for the travel insurance cannot be covered by the project.

#### Reimbursement of travel expenses

Participants will be reimbursed for their travel expenses up to the amount available for their countries and no more than their real costs. In order to get reimbursed for their travel expenses, participants shall send the organizer all the originals of travel documentation and invoices. The reimbursements will be made through bank transfers within 45 days after the organizer have received the original documentation by post.

Additionally, the reimbursement will be performed only if the following conditions are met:

- 1. Participants submit their individual participant report as requested by the European Commission through the Mobility Tool.
- 2. Participants and their sending organizations send the organizers a proof of dissemination activities.

## **Programme**

Attached to this call for participants is the draft programme of the training course. Please note that some changes in the programme could potentially be made.

Participants in the training course will develop non-formal methods and best practices on promoting the concept of democracy amongst young people and are expected to actively contribute to the activities. In this regard, the selected participants will be required to send in advance examples of non-formal education methods or best practices within the following topics:

- National and international politics, media literacy, and social life.
- Democracy and European value and policy.
- Populism and how to fight it.

#### **Dissemination**


